

**PLATTE COUNTY R-3 HIGH SCHOOL
2020-2021 PARKING APPLICATION**

Operation of a motor vehicle on school property is a privilege granted by the Board of Education through the school's administration, and not a right guaranteed to each student. This privilege can be suspended and/or revoked at any time, based on the judgment of the school administrators. The parking permit must be displayed on the rear view mirror.

By signing/submitting this document, the student agrees to the following:

- Will not park in a reserved location or spot.
- Will only park in designated student parking lots.
- To operate the vehicle at a safe speed while on school property.
- To operate the vehicle in a careful and prudent manner, yielding the right of way to pedestrians and school owned vehicles.
- To park the vehicle in the properly assigned area and within marked lines with that area. Students parking in any area of school property not specifically designated to a student, is done without the consent of the person(s) in control of such property; a parking summons may be issued to vehicles in violation of outlined policy in accordance with Platte City ordinance.
- To make their vehicle available for search by the school administrators in the presence of the driver. Failure to do so after a request will result in immediate revocation of parking privileges and other disciplinary action as determined by administration.
- You must have a car before signing up for a parking pass.
- You must provide proof of valid insurance and driver's license. Please email a copy of your student's insurance and driver's license to pchsparking@platteco.k12.mo.us
- Licenses acquired after the sign up day may apply at a later date.
- The permit is not transferable and must be returned upon withdrawal or early graduation. The permit and is not to be re-assigned or used by another student.
- First time parking violators will receive a verbal warning. Second time parking violators will receive 30 school days suspension of parking privileges. Third time parking violators will be terminated from Parking for the remainder of the school year. Money will not be refunded. Vehicles may also be towed at the owner's expense from any Platte County R-3 Schools property for continued violations of this policy.

During Fall Registration in August – the \$25.00 parking fee will be accessed for students who have submitted/requested Parking. The fee will need to be remitted at that time, before the tag will be issued. Please note: If any changes are needed to parking assignments, there will be an announcement made to students during the school day.

My student and I understand that any violation of the rules and regulations will result in the suspension and/or revocation of driving privileges on school property.
